**Sub: Symbolic possession of Distillery unit at Chagallu**

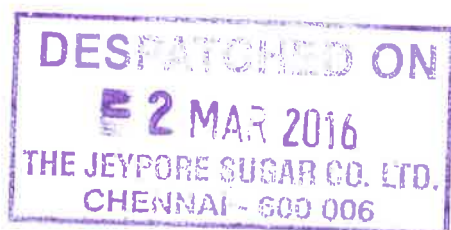
